COMPLAINT

18 I, the undersigned, say, on information and belief, that in
19 the County of Yolo, State of California:

20
21 FOR ATTACK IN CEMETERY:

22
23 Count 1 : On or about November 28, 2015, MICHAEL ISAIAH
24 HERNANDEZ did commit a FELONY, namely, a violation of Section
25 209(b)(1) of the California Penal Code, KIDNAPPING FOR RAPE AND
26 ORAL COPULATION, in that MICHAEL ISAIAH HERNANDEZ did willfully
27 and unlawfully kidnap and carry away another person,
28 Confidential Victim #1, to commit RAPE AND ORAL COPULATION.

1 Count 2 : On or about November 28, 2015, MICHAEL ISAIAH
2 HERNANDEZ did commit a FELONY, namely, a violation of Section
3 220(a)(2) of the California Penal Code, ASSAULT WITH INTENT TO
4 COMMIT SEX CRIME ON MINOR in that MICHAEL ISAIAH HERNANDEZ did
5 unlawfully assault C.V. #1 with the intent to commit rape and
6 oral copulation.

7 It is further alleged that at the time of said assault,
8 C.V. #1 was a minor under the age of 18.
9

10 Count 3 : On or about November 28, 2015, MICHAEL ISAIAH
11 HERNANDEZ did commit a FELONY, namely, a violation of Section
12 136.1(b)(2) of the California Penal Code, DISSUADING A WITNESS,
13 in that said MICHAEL ISAIAH HERNANDEZ did willfully and
14 unlawfully attempt to prevent and dissuade another person who
15 had been the victim of a crime [C.V. #1] from causing a
16 complaint, indictment, information, probation and parole
17 violation to be sought and prosecuted, and assisting in the
18 prosecution thereof.

21 FOR THE CONTINUOUS CONDUCT OF HITTING AND CHOKING THE
22 VICTIM:
23

24 Count 4 : On or about November 28, 2015, MICHAEL ISAIAH
25 HERNANDEZ did commit a FELONY, namely, a violation of Section
26 273.5(a) of the California Penal Code, INFLICTION OF CORPORAL
27 INJURY ON FIANCE OR PERSON WITH WHOM DEFENDANT HAS A DATING OR
28 FORMER DATING RELATIONSHIP, in that MICHAEL ISAIAH HERNANDEZ did

1 willfully and unlawfully inflict corporal injury resulting in a
2 traumatic condition upon MICHAEL ISAIAH HERNANDEZ's fiance or
3 person with whome MICHAEL ISAIAH HERNANDEZ has a dating or
4 former dating relationship.

6 FOR DRAGGING VICTIM DOWN THE STREET AFTER THE CEMETERY
7 ATTACK:

8
9 Count 5 : On or about November 28, 2015, MICHAEL ISAIAH
10 HERNANDEZ did commit a FELONY, namely, a violation of Section
11 207(a) of the California Penal Code, KIDNAPPING, in that MICHAEL
12 ISAIAH HERNANDEZ did willfully, unlawfully, forcibly, and by any
13 other means of instilling fear steal, take, hold, detain, and
14 arrest any person, to wit, C.V. #1, in the State of California,
15 and MICHAEL ISAIAH HERNANDEZ did carry such victim into another
16 country, state, and into another part of the same county.

17
18 Count 6 : On or about November 28, 2015, MICHAEL ISAIAH
19 HERNANDEZ did commit a FELONY, namely, a violation of Section
20 136.1(b)(1) of the California Penal Code, DISSUADING A WITNESS,
21 in that MICHAEL ISAIAH HERNANDEZ did willfully and unlawfully
22 attempt to prevent and dissuade another person who had been a
23 witness to a crime from making a report of such victimization to
24 any peace officer[For Telling Witness Jason Squires "No Cops"].
