RE: Beard, Timothy AA8859

Dear Board of Parole Hearings,

Thank you for the opportunity to address the Board regarding the administrative review of inmate Timothy Beard, CDC AA8859, and his suitability for early release.

Based upon his criminal history and the facts of his recent cases, Mr. Beard poses an unreasonable risk and should be not considered for early release.

Mr. Beard has an extensive criminal history, including recent convictions for residential burglary, transporting methamphetamine, and possession of a concealed weapon. His burglary and transporting methamphetamine conviction happened within a couple of months of each other, and were followed up by his arrest and conviction in the instant case. Indeed, the deputy who arrested Mr. Beard based his search of Mr. Beard's vehicle on his status as a parolee.

In the instant case, Mr. Beard was found parked in a remote area of Yolo County. A search of his person found that he was in possession of \$3990 in various different denominations. In the glove box, the deputy found an additional \$1880. Inside the passenger compartment, the deputy found seven cell phones, methamphetamine paraphernalia and a stun gun.


Additionally, the deputy located five different quantities of methamphetamine, weighing a total of 3.75 ounces, approximately 107 grams. Based on all of the items found, including the money, the cell phones, and the amount of methamphetamine, it was obvious that Mr. Beard was involved in the sales of methamphetamine.

Mr. Beard clearly poses a risk to re-offend and should not be considered for early release. His crimes in this case occurred when he was on parole. Further, he lied to law enforcement about what he was on parole for, demonstrating a willingness to deceive. Further, he indicated to the deputy that he was unaware of anything illegal in the vehicle, yet he was heard on an in-car camera asking his co-defendant if the deputy had located the methamphetamine when the deputy began looking through the container it was found in.

While Mr. Beard does not have a demonstrated history of violence, he has shown a disregard for the conditions of his parole, committing the same types of offenses that have landed him in prison initially. Further, when given the opportunity to come clean and be honest with law enforcement, he has consistently and repeatedly chosen to lie and deceive. For all of these reasons, Mr. Beard should not be considered for early release.
