 18 I, the undersigned, say, on information and belief, that in  
 19 the County of Yolo, State of California:

20 Count 1: On or about November 19, 2017, MARKEESE LEAVELL  
 21 CARTER did commit a FELONY, namely, aviolation of Section 187(a)  
 22 of the California Penal Code, FIRST DEGREE MURDER, in that  
 23 MARKEESE LEAVELL CARTER did willfully and unlawfully kill a  
 24 human being, to wit, A.A., with malice aforethought.


25 Count 2: On or about November 19, 2017, MARKEESE LEAVELL  
 26 CARTER did commit a FELONY, namely, a violation of Section  
 27 288.7(b) of the California Penal Code, SEXUAL ACT WITH CHILD 10  
 28 YEARS OLD OR YOUNGER, in that MARKEESE LEAVELL CARTER a person

1 18 years of age or older, did willfully and unlawfully engage in  
2 Sexual Penetration , with a child 10 years of age or younger.

3 Count 3: On or about November 19, 2017, MARKEESE LEAVELL  
4 CARTER did commit a FELONY, namely, a violation of Section 69 of  
5 the California Penal Code, RESISTING EXECUTIVE OFFICER BY MEANS  
6 OF THREATS, FORCE OR VIOLENCE, in that MARKEESE LEAVELL CARTER  
7 did willfully and unlawfully attempt, by means of threats and  
8 violence, to deter or prevent Juan Ceja, an executive officer,  
9 from performing a duty imposed upon such officer by law and did  
10 willfully, unlawfully, and knowingly resist, by the use of force  
11 or violence, such officer, in the performance of said officer's  
12 duty.
