JURISDICTIONAL REVIEW

Decision based on the reasons stated below:

APPROVAL

Decision: When considering together the findings on each of the four case factors, both aggravating and mitigating, they do not tend to show that Mr. Jaramillo poses an unreasonable risk of violence to the community. Accordingly, Mr. Jaramillo is approved for release.

Case Factor #1- Current Commitment Offense

Mr. Jaramillo's current commitment offense, VC10851(a) Vehicle Theft, is a mitigating factor in this case. On 12/1/15, Mr. Jaramillo was in possession of a stolen vehicle. When confronted by the victim, the vehicle owner, Mr. Jaramillo ran away.

Mr. Jaramillo entered a plea agreement and was sentenced to a total term of four (4) years on the current commitment offense.

Under the review criteria, no aggravating circumstances are present.

The mitigating circumstances are: 1) No weapon was used; 2) No violence or threat of violence occurred; 3) No physical injury to a victim occurred; and 4) The crime involved property theft.

When reviewing the mitigating circumstances and lack of any aggravating circumstances, Mr. Jaramillo's current commitment offense is a mitigating factor because it is a non-violent property crime.

Case Factor #2- Prior Criminal Record

Mr. Jaramillo's prior criminal record is a mitigating factor in this case. His prior criminal history, which began in 2006 and continued until the commitment offenses in 2015, includes the following serious juvenile adjudications and/or adult felony convictions:

1. 2006: PC459 Burglary First Degree; and

2. 2006: PC496(a) Receiving Stolen Property.

The only aggravating circumstance under the review criteria is that less than five (5) years elapsed between Mr. Jaramillo's release from a prior incarceration on 4/24/12, and the current offense on 12/1/15.

The mitigating circumstances are: 1) Mr. Jaramillo has been convicted of only two (2) or fewer felonies; and 2) His prior felony convictions were for property crimes.

When balancing the aggravating circumstance against the mitigating circumstances, Mr. Jaramillo's prior criminal record is a mitigating factor because he has been convicted of only two (2) felonies, both of which were for non-violent property crimes.

Case Factor #3- Institutional Adjustment

Mr. Jaramillo has been incarcerated on the commitment offense since 3/17/16, a period of approximately twenty (20) months.

During incarceration, Mr. Jaramillo has not incurred any RVRs or 128-A Counseling Chronos. He has participated in or completed the following positive programming: Phoenix House 12-Week Substance Abuse Program, Alcoholics Anonymous, Narcotics Anonymous, Anger Management, Transitions, and Mule Creek Prison's 9th Annual National Crime Victim's Week (which included MADD, GRIP, and Operation Care). Mr. Jaramillo also received a Certificate from ServSafe California for Food Handler Assessment and participated in educational upgrades.

After reviewing the positive factors and lack of any negative factors, Mr. Jaramillo's institutional record shows overall compliance with institutional rules and is a mitigating factor.

Case Factor #4- Response to Legal Notices

A response to the Legal Notices in support of release was received. A letter from Mr. Jaramillo, dated 8/22/17, was reviewed and considered in the decision.

A response to the Legal Notices in opposition to release was also received. A letter from the Yolo County District Attorney's Office, dated 3/6/17, was reviewed and considered in the decision.

SUMMARY: Under the review criteria, Mr. Jaramillo's commitment offense, prior criminal record, and institutional behavior are all mitigating factors. Mr. Jaramillo's current offense and prior criminal record involve non-violent property crimes. During his incarceration, Mr. Jaramillo has not incurred any rules violations, and has participated extensively in positive programming. Based on the foregoing, Mr. Jaramillo is approved for release.
