Purpose


Provide mental health services, substance use disorder treatment and diversion programs for people involved in the criminal justice system

■ Target Population

People arrested, charged with, or convicted of a criminal offense <u>and</u> who have a history of mental health and/or substance use disorders

■ Grant Term

Implementation – August 15, 2019-December 31, 2019 Service Delivery – January 1, 2020-December 31, 2022 Data Evaluation – January 1, 2023-May 15, 2023


Neighborhood Court Completion Rate




- Over 1,600 cases have been resolved through Neighborhood Court since 2013.
- Agreements are flexible; due dates are based on what is attainable for the
 participant, decided in collaboration with the volunteers, and extensions are
 granted by program staff upon request when the participant expresses that need.





 - Mental Health and/or Substance Use Condition
- •and
 - · Homeless or who have a history of homelessness

Partners

- Community Based Organizations (TBD)

Funding

- •Up to \$6M over 45 months
 - 36-40.5 months of services
- •30% with County
- •70% to CBOs
 - Sole Source and Competitive RFP process



Diversion Component

- □ All project participants must first be approved by the District Attorney's Office, and then voluntarily opt in for participation in the Homeless Neighborhood Court Diversion Program
- ☐ If an individual is not demonstrating successful engagement and participation within 6 months, he or she may be referred to another mental health or substance use program, with a redetermination of continued eligibility for diversion

Program Enrollment – Outreach

- □ Conducted at a range of locations and with multiple community partners
 - ☐ Law enforcement
 - ☐ Homeless Coordinators
 - □Local jail
 - □ Emergency departments
 - ☐ Other settings frequented by individuals living homeless, such as shelters and food resource locations

Program Enrollment – Assessments

- □ Assess potential participants
 - □ Self Sufficiency Factors
 - □ Housing
 - ☐ Behavioral and Physical Health
 - ☐ Criminal Justice Involvement
 - □Income

Program Enrollment – Case Management

- □ Targeting identified needs in the areas of Self Sufficiency
 - Housing
 - ID, applications
 - Flexible funding for housing related supports
 - Behavioral and Physical Health
 - Behavioral Health Mental Health and Substance Use Disorder Treatment
 - Linkage to other Supports, such as Physical Health Care and Civil Legal Services
 - Criminal Justice Involvement
 - Risk of recidivism
 - Income
 - Medi-Cal, Cal Fresh, SSI or other sustainability support for the long-term
