18 I, the undersigned, say, on information and belief, that in
19 the County of Yolo, State of California:

20 Count 1 : On or about February 15, 2021, DERRICK DIMONE
21 WOODS did commit a FELONY, namely, a violation of Section 187(a)
22 of the California Penal Code, MURDER, in that DERRICK DIMONE
23 WOODS did willfully and unlawfully kill a human being, to wit,
24 A.O., with malice aforethought.

25 Count Enhancement 1a : It is also alleged that DERRICK
26 DIMONE WOODS is subject to a SPECIAL CIRCUMSTANCE FOR TORTURE
27 within the meaning of Section 190.2 (a) (18) , in that the
28 defendant inflicted torture in the commission of murder.

1 Count 2 : On or about February 15, 2021, DERRICK DIMONE
2 WOODS did commit a FELONY, namely, a violation of Section 273ab
3 of the California Penal Code, ASSAULT ON CHILD UNDER EIGHT WITH
4 FORCE LIKELY TO PRODUCE GREAT BODILY INJURY RESULTING IN DEATH,
5 in that DERRICK DIMONE WOODS while having the care and custody
6 of a child who was under eight years of age did willfully and
7 unlawfully assault said child by means of force that to a
8 reasonable person would be likely to produce great bodily injury
9 and such assault did result in said child's death.

10 Count 3 : On or about February 15, 2021, DERRICK DIMONE
11 WOODS did commit a FELONY, namely, a violation of Section
12 273a(a) of the California Penal Code, ABUSING OR ENDANGERING
13 HEALTH OF A CHILD, in that DERRICK DIMONE WOODS did willfully
14 and unlawfully, under circumstances and conditions likely to
15 produce great bodily harm and death, cause and permit a child to
16 suffer, and DERRICK DIMONE WOODS did inflict thereon
17 unjustifiable physical pain and mental suffering, and having the
18 care or custody of said child DERRICK DIMONE WOODS did willfully
19 cause and permit the person and health of said child to be
20 injured, and DERRICK DIMONE WOODS did willfully cause and permit
21 said child to be placed in such a situation that the child's
22 person and health was endangered.

23 Count Enhancement 3a : It is further alleged that during
24 the commission of the felony charged above DERRICK DIMONE WOODS
25 did willfully, unlawfully, and personally inflict great bodily
26 injury upon a child under the age of five years in the
27 commission of a felony, within the meaning of Section 12022.7(d)
28 of the California Penal Code, INFLECTION OF GREAT BODILY INJURY

1 UPON A CHILD UNDER FIVE YEARS OF AGE DURING THE COMMISSION OF A
2 FELONY.

3 I declare under penalty of perjury that the foregoing is
4 correct.
